SMW006 Work with Quotation Contracts

Overview

Quotation contracts assists with the automation of ISA Quote processing within Bookmaster where the quote is entered into Bookmaster and can subsequently be maintained and converted into an order.

When creating the Quotation Contract, multiple accounts can be selected, listing all the current subscriptions. The Sub Lists default the price from the Item Price File allowing changes to price discount and quantity. The quotation contract includes a description of the account, the intended start date and list of subs orders. The quotation can be output to a file or a quotation invoice.

To simplify debtor reconciliations a list showing all outstanding charges and calculated pro-rata credits due on paid invoices display.

When the quotation is accepted, the contract is converted to an order in the order entry screen for review. At this stage an account number must be nominated. The order creation requires a link for each subs list into an ISBN. The order will then be processed through the system (via pending) into an invoice.

Purpose

This program displays records in the quotation contract header file and allows options to add a quotation contract, maintain the header/detail, cancel contract, export to Excel spreadsheet, and do an order entry for a quotation contract. Existing contracts can also be copied.



Example 1: Add a quotation contracts

This example describes how to add a quotation contract.

1. Select menu item **Work with Subs Quotation Contracts** from Publishing Modules>Subscription Management>Quotation Contract>Maintenance menu.



Example 4: Cancel quotation contract

Example 5: Export file

This example describes how to delete discount by site.

- 1. Repeat steps 1 and 2 as in Example 1: Add a quotation contracts
- 2. Select contract and click File Export.

3. Enter the output path/name for the download and click **OK**.

Example 6: Order entry for quotation contract

This example describes how to enter order for quotation contract.

- 1. Repeat steps 1 and 2 as in Example 1: Add a quotation contracts
- 2. Select contract and click Order entry.
