# 1. Introduction

IBS Bookmaster system has been enhanced to enable Curbstone CorrectConnect (C3) payment gateway system to process credit card processing.

Curbstone CorrectConnect (C3) is an online payment management system widely used by business in United States and Canada. With Curbstone CorrectConnect (C3) all card data storage is offloaded to the Curbstone portal.

IBS Bookmaster customers that use Curbstone CorrectConnect (C3) for their online credit card payment processing can use this document to setup and configure their systems to process payments.

This document outlines IBS Bookmaster configurations and setups only. Installation instructions for CorrectConnect (C3) is not included in this documentation; it must be sourced from Curbstone directly.

## 1.1 Purpose

The purpose of this document is to assist IBS consultants' setup and configure appropriate business rules in IBS Bookmaster at a customer site for Curbstone CorrectConnect (C3) processing.

## 2. Setup & Configuration

Business rules for Curbstone CorrectConnect (C3) Payment Gateway must be setup with support from IBS consultants.

**Note:** The following configurational setups & business rules have to be setup for Curbstone CorrectConnect (C3). This document does not cover customised setup tasks of specific companies. Deviations from this setup should be covered by setup tasks written by individual companies.

### 2.1 C3 Installation

Install CorrectConnect (C3) as per instructions from Curbstone.

### 2.2 Bookmaster Control Files/Merchant Details Maintenance

1. In Bookmaster create/update the following control files:

2. Set default merchant to Curbstone via Merchant Detail Maintenance (XAW630A) if not already done.

3. Increase 'XA-TRNID Credit card transaction ID' control number to higher round number (for example - '00100000').

**NOTE:** Please refer to SOP Payment Manager – Credit Card Processing for all other control files that needs to be setup for standard credit card processing IBS Bookmaster.

## 2.3 Add IBS Bookmaster Users to IPT User Management Interface via C3IPT

All IBS Bookmaster users who will be doing payment processing in IBS Bookmaster should be added as an IPT user via C3IPT. The username must match the username of the AS/400 user profile and the password is case sensitive.

The following is an example of adding an IPT user.

### Relevant fields

Customer: Curbstone customer number for your organization.

User: The username must match the username of the AS/400 user profile.

Password: Password is case sensitive.

Credits: Enter 'Y' to allow the user to generate credits through IPT.

### 3. Payment Process

When a payment is to be processed in IBS Bookmaster the system will direct to the C3 Web portal for credit card data entry.

The following is a test sample payment process using Curbstone CorrectConnect (C3).
